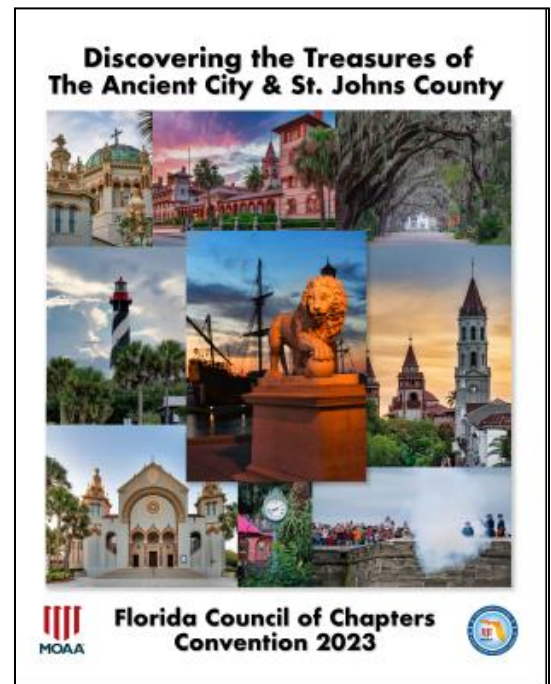
Let's keep up the momentum to build stronger chapters and grow our numbers. Let me know if you have any questions.

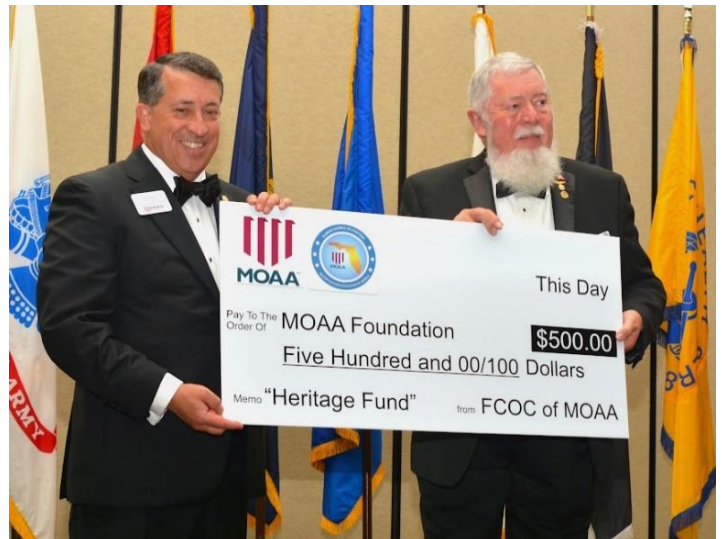

## Chaplain's Message

“The Lord said to me: ‘Go, set a watchman.’” Isaiah 21:6

Many of us who attended the Florida Council of Chapters Convention in May (National Suicide Prevention Awareness Month) learned about The Fire Watch's state-wide efforts to end veteran suicide. And I want you to join me along the watchtower as a Watch Stander in your community to end veteran suicide. You too can become a Watch Stander to identify the warning signs of veterans in crisis and to direct those Veterans to the help they need.

We are all familiar with the high rates of suicide of among veterans and becoming a Watch Stander through The Fire Watch, includes you in Florida's fight to end veteran suicide. The training, endorsed by the Florida Department of Veterans' Affairs and the Governor's Challenge to Prevent Suicide Among Service Members, Veterans, and their Families is free, online, takes about an hour to complete, and effectively equips you to be vigilant to the concerns of veterans and to direct them to the support they need.

The Fire Watch model, patterned after CPR, is the first of its kind in the country. It's not therapy. It's not counseling. It is, however, an uncomplicated way to steer a veteran off the path to suicide and toward the MANY helping resources we have available in Florida.

And yes, you can be a Watch Stander. Fire Watch asks that you view 2 or 3 short training videos, explore a guide of resources available to veterans and sign a pledge. Then they ask that you get out there – on social media, in networking groups, in person, in your community – to stand watch and to save lives.

I became a Watch Stander over a year ago and I hope you will join me in this grass roots effort to reduce veteran suicides in our community. You can be the one to save one veteran. Stand with me along the watchtower by becoming a Watch Stander.

### Credit Card Fraud

In a six week period, I had *four* different credit card numbers. Say what?!?

Four times over a six week period, I received texts from my two credit card banks asking me to confirm transactions. All four times, I had a fraudulent charge on my account. All four times, they immediately blocked my card, reversed the fraudulent charge, and sent me a new card. Amazingly, one of the fraudulent charges was on a card that I had just received and activated, but had not yet even used! So what can one do?

I'm unsure how my cards' numbers were compromised so I'll not dwell on it. Like most people, I do not flash them around. Unlike most folks, I avoid doing any auto pays to a credit card. When you have a vendor store your card number and routinely charge it, they obviously have to store it. You are totally dependent on *their* security. Who knows how good that is?

More importantly, when your credit card number is compromised, you need to go to each vendor and update that number. This... can be a real pain.

I actually take the opposite approach. I have *no* auto pays on any cards. I keep two independent Visa cards from two different banks. One of them gives a three percent rebate on gasoline and restaurant purchases. That gets all gas purchases and dinners out. The other gives points that



convert into airline tickets quite favorably. Each backs up the other when one is compromised and is not available for a few days.

(I lied. I have one autopay - Amazon. You can't *not* have a credit card with them.)

So how do you pay all those bills that are not on auto pay to a credit card? *Web-bill-pay*. Different banks call it different things but they all work just about the same. You get a recurring bill. You load it into the bank's web-bill-pay system, and when you get a bill, you click on the vendor, put in the dollar amount, and click on "send." The bank sends the money to the vendor.

Here's the beauty of this. The payment includes your account number with the *vendor* but *not* your credit card number (or your checking account number, if you use ACH debits). If there's a fraud, it's on the bank's account. You are bullet proof.

Most national vendors are set up for electronic payments from the banks, so you can set it to pay your bills on the due date. Think all phone companies, cable companies, and electric companies. Many do e-billing so that you get an e-bill, you look at it, and if it's correct, do nothing. The bank pays it on the due date. You can also pay your landscaper and HOA, but they will receive a paper check in the mail.

I mentioned ACH debits. This is where you give a voided check to a vendor and they simply pull the money from your checking account when the bill is due. I was talking with a neighbor. She knows that I'm a big fan of web-bill-pay. She uses ACH debits for everything, and her *checking account...* was compromised! It took her two months to get her direct deposits working again and she had to battle with several vendors to avoid paying late fees when her ACH debits failed. Needless to say, she's converting to web-bill-pay.

Recently, there was an article in the Wall Street Journal. Florida is the *number one* target for credit card fraud. A large, elderly, not-very tech savvy population... is an easy target.

Short follow up: Debit cards. The only thing you should use a debit card for is as an ATM card. With a credit card, the most you can lose in a fraud is \$50. The bank eats the rest. Not so with a debit card. If there's a fraud, you could be liable for *100% of the loss*.

Some people are leery of ATMs. I think they're pretty safe. I've never heard of an error in getting cash from one, and if you're smart about choosing one, they're very safe. I do all my banking at the "First Bank of Publix." There's an ATM in front of every Publix and there are always people walking by, at least during business hours. And I walk in there several times a week.

Two buddies were walking through the woods in Alaska. They noticed a grizzly bear following them. One of them stops, removes his backpack and starts changing out of his hiking boots into running shoes. The other says "are you nuts? You can't outrun a grizzly." He responds "I don't have to outrun the bear. I just have to outrun *you*."

You don't need to outsmart every fraudster. All you need to do is be a harder target than everyone else. A couple credit cards from banks with good fraud departments, and web-bill-pay are a pretty good pair of running shoes.

Now that the 2023 FCoC Convention is done we can start to look forward to the 2024 Convention. Please MARK YOUR CALENDARS with the dates of this convention ...12 to 15 May 2024. Yes, when you do mark your calendars, you'll see that those dates are a Sunday through to Wednesday. For this convention we are going for a mid-week convention instead of the traditional weekend for several reasons. First, it is less busy during weekdays so we will have the opportunity to do our convention activities without trying to fit them in with competing non-FCoC activities. Second, in arranging for a convention hotel, particularly in a high tourist area, we found greater availability – and cheaper costs – going mid-week.

Speaking of our hotel venue, what is it and where is it? The 2024 convention will be held in Daytona Beach at The Shores Resort & Spa. The Shores is right on the beach with direct beach access, located off A1A in Daytona Beach Shores, which is just south of the main part of Daytona Beach. If you'd like to see more of our selected hotel, please go to [www.shoresresort.com](http://www.shoresresort.com).

Daytona Beach, as many of you already know, is a particularly popular tourist destination for both locals and out-of-staters. There are a many great things to do and see as well as, of course, soak in the rays on the beach itself. To mention just a few, there's Daytona International Speedway, home of NASCAR, which has various experience options; the PGA championship courses where you can indulge your golfing self; the Museum of Arts and Sciences and the Cici and Hyatt Brown Art Museum; Ponce Inlet Lighthouse and Museum; and historic downtown Daytona Beach.

As articles are placed in the Communiqué' in the coming months, I'll add other things to see and do while in Daytona Beach. So many ...that you are encouraged to take advantage of staying at The Shores for two extra days, Wednesday and Thursday, at the same room cost as for the convention itself. More information will be provided as we get closer to the convention but whatever you do put these dates in your calendar and mark them as "must do"!

## MOAA Advocacy-in-Action April 26, 2023

Although it was a very busy day on Capitol Hill with committee hearings and other legislative work, our 5 Florida teams were able to visit the offices of all 28 Florida Representatives, and both our Senators, meeting with staff (and a few of the legislators themselves) and providing detailed MOAA Point Papers on the three AiA topics to reinforce our discussions.

These three AiA Issues will be in the forefront of MOAA's agenda through the remainder of this legislative session

Restore BHA to 100%

Reverse Tricare Pharmacy Network Cuts

Support the All-Volunteer Force – *Stop the 20 year Erosion of Quality-of-Life Benefits*

**Yet, there have already been new “campaigns” for carry-over issues that were not attended to by Congress in last year’s session:**

Urge your Representative to co-sponsor H.R. 1045, The Health Care Fairness for Military Families Act, to ensure military kids transitioning to adulthood have the same health care protections as their peers in civilian families. This bill brings TRICARE in line with commercial plan requirements for young adult coverage that have existed for more than a decade by eliminating monthly premiums for TRICARE Young Adult coverage.

Write your Representative to ask him/her to support H.R. 1413 The Expanding America's National Cemetery Act and ensure it is either enacted as standalone legislation or included in the FY 2024 National Defense Authorization Act.

*Arlington National Cemetery (ANC) eventually will run out of room, and proposed eligibility reductions will end the benefit some veterans and their families have planned on for years.*

This Bill would authorize the transformation of a VA-run national cemetery into the next location that affords military honors as ANC reaches capacity.

**Protecting this benefit for those currently eligible, and their families, is a matter of national conscience.**

Contact your representative and senators to seek their support of S. 596/H.R. 1277, The Military Spouse Hiring.

*According to DoD's 2021 Active Duty Spouse Survey, military spouses face a staggering unemployment rate – over five times the national figure. Military spouse unemployment not only impacts the financial well-being of military families, but it is also a retention issue. Nearly one-third of servicemembers cite concerns with spouse employment as part of their decision to leave service.*

The Work Opportunity Tax Credit was established to incentivize the hiring of specific groups that face significant barriers to employment. This legislation will create a target group for military spouses who struggle to maintain employment due to frequent military-mandated moves.

A recent Congressional Budget Office report includes two proposals to cut the deficit that would increase costs for seniors using the TRICARE for Life (TFL) benefit. Congress needs to be aware of the multi-faceted consequences any effort to increase out-of-pocket costs for TRICARE for Life (TFL), would have.

With CBO's proposals, seniors could face up to \$4,675 in additional health care costs per year. The TFL benefit was a key component of the compensation and benefits package that sustained the all-volunteer force throughout two decades of war – it must not be slashed just as the cohort that served their entire career during wartime is transitioning to retirement.

Urge your representative and senators to oppose any proposal that increases costs for working age military retirees as well as for those military retirees who have Medicare Parts A and B. and rely on TFL for their health care.

**Our nation must fulfill its obligations to those who served a full career in uniform.**

Although it was a very busy day on Capitol Hill with committee hearings and other legislative work, our 5 teams were able to visit the offices of all 28 Florida Representatives, and both our Senators, meeting with staff (and a few of the legislators themselves) and providing detailed MOAA Point Papers on the three AiA topics to reinforce our discussions.

This Advocacy Campaign left all of us physically tired (Renee and I did over 14,000 steps – they call it Capitol HILL for a reason!!) and up and down stairs in two buildings. But emotionally and mentally we were energized by the positive engagements we had fulfilling MOAA's motto **“Never Stop Serving”**.

Bob will be closely following and reporting on what happens to the bills addressing the issues that were advocated for this week, and on several others MOAA is hoping to see advance in this year's legislative cycle.





## Florida Department of Veterans Affairs Update

### Governor Ron DeSantis Signs Legislative Package to Support Florida's Military Members and Their Families

**TALLAHASSEE, Fla. – May 26, 2023** Today, Governor Ron DeSantis signed eight bills to support Florida's military members and their families. Florida is the most military-friendly state in the nation and is home to nearly 1.5 million veterans, the third largest veteran population in the country. Bills signed by the Governor will support veteran education and training opportunities, expand veteran benefits, and strengthen long-term care for Florida's veterans and their families. "Florida is the most military and veteran friendly state in the nation and through this legislation, we are further supporting our military, veterans and their families with the resources they need while they are serving and after they have fulfilled their duty," said **Governor Ron DeSantis**.

Senate Bill (SB) 732 establishes the Collegiate Purple Star Campuses Program to support military members, veterans, and their families while they are attending a Florida college or university. This bill requires institutions who wish to be designated a Collegiate Purple Star Campus to:

- Designate a staff member as a military liaison.
- Maintain a webpage on the institution's website which includes resources for military students and families.
- Maintain a student-led transition program that assists military students in transitioning into the institution.
- Offer staff members professional development training opportunities that will help them better serve military students.
- Provide priority course registration for military students.

SB 274 creates the "Pathway for Military Combat Medics Act." The Act will give military combat veterans postsecondary course credit for their military combat medic training to be used toward a nursing education program. This will allow veterans to earn their nursing education degree more quickly and at a lower cost.

House Bill (HB) 139 makes it easier for military veterans and their spouses to transition to civilian life in Florida. This bill establishes the Office of Veteran Licensure Services within the Department of Health to provide information and assistance with health care licensure processes for all veterans and their spouses. Additionally, this bill requires Veterans Florida to assist veterans and their spouses with access, training, education, and employment in Florida's health care professions.

HB 485 creates the Division of Long-term Care within the Florida Department of Veterans Affairs (FDVA) to oversee the operations of veterans' adult day health care programs. Additionally, the bill expands eligibility requirements for veterans who wish to enter an adult day health care program and names the week of November 11<sup>th</sup> of each year as "Veterans Week."

HB 635 supports veterans who need dental care by creating the Veterans Dental Care Grant Program within the FDVA to provide dental care to Florida's veterans. The US Department of Veterans Affairs (VA) reports that only 15% of veterans are eligible to access dental services through the VA. This program will distribute grants to eligible nonprofits that provide dental care to veterans in Florida.

SB 574 supports servicemembers that are living in Florida who receive military orders to live in government quarters and who must terminate an existing lease agreement. This bill defines the term "government quarters" to include privately owned military housing. This will enable servicemembers to early terminate a private rental agreement if they become eligible for privatized military housing.

HB 621 supports military families by establishing a uniform death benefit for active duty servicemembers of \$75,000. Currently, servicemembers who are killed while on active duty and while performing their official duties are eligible for a death benefit of \$75,000 while servicemembers who are killed while on active duty but not while performing their official duties are only eligible for a death benefit of \$25,000.

HB 1285 establishes the Florida State Guard as a permanent component in Florida's state militia and creates the Division of the State Guard within the Department of Military Affairs. The Florida State Guard has been appropriated \$108 million in the General Appropriations Act.



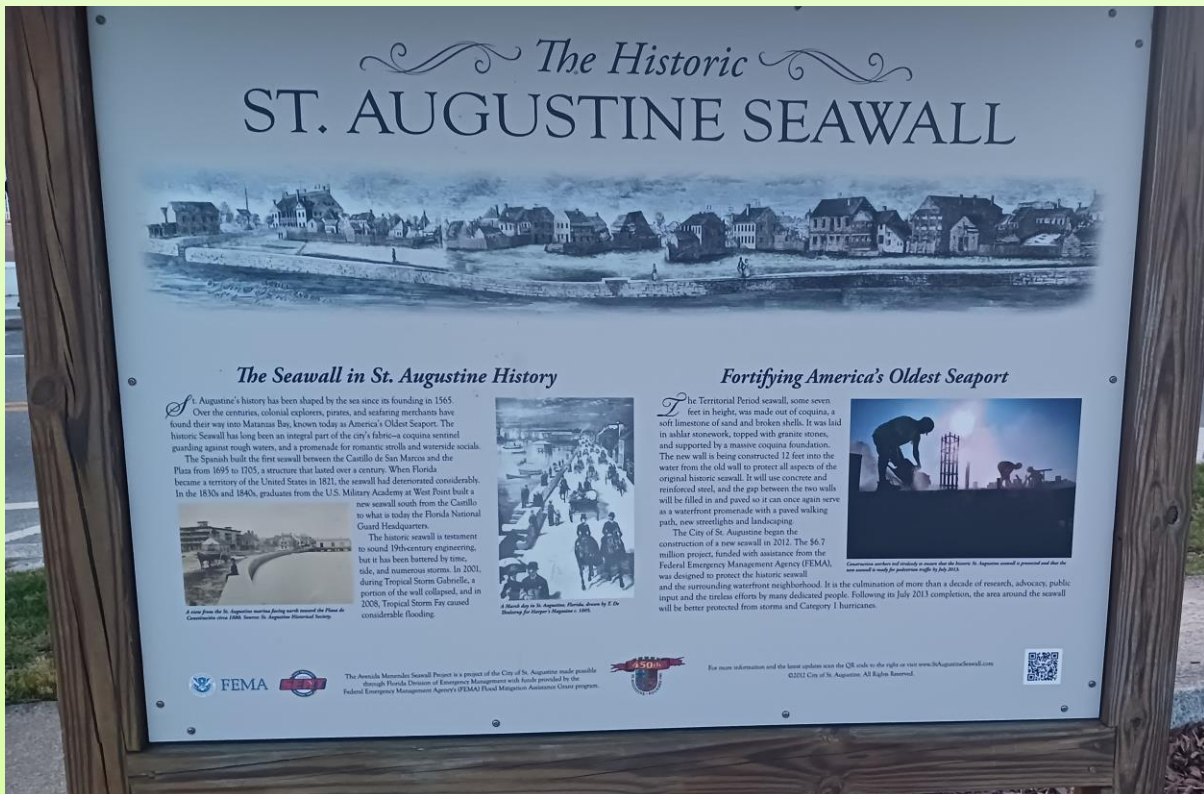
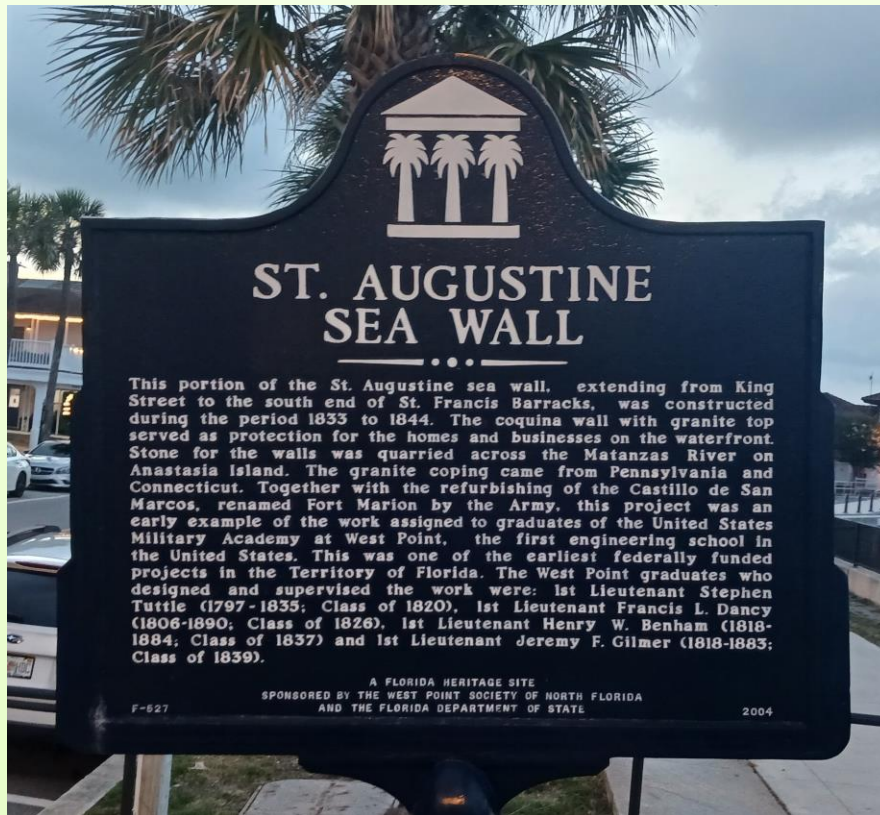

The success of the Cadet of the Year scholarship program depends upon nominations of deserving cadets by the senior JROTC instructor at one of the 32 high schools in Orange, Osceola and Seminole counties with JROTC detachments. The nominations are accompanied by a written recommendation from the nominating senior instructor.

Each cadet nominated is interviewed in dress uniform by a diverse selection committee composed of three members of the Chapter. The interviews last approximately 15-20 minutes. Factors considered by the selection committee include, but are not limited to: military bearing and appearance in uniform, cadet JROTC assignments, Advanced Placement and Honors classes being taken or completed, GPA, school activities, service in the community and plans for future military service. The Chapter believes the cadets benefit from the interviewing process whether or not they win a scholarship because they will be interviewing for positions throughout their lives.

The Chapter has awarded 69 scholarships the past eight years. These scholarships were awarded to cadets representing over 50% of the JROTC detachments in the three-county area.

**On May 9<sup>th</sup>**, we hosted Dr. Deborah C. Beidel, Ph.D, ABPP, Executive Director of UCF Restores. Dr. Beidel talked about “Do We Need Different Treatments or Do We Need to do Treatments Differently.” UCF RESTORES is a clinical research center dedicated to changing the way that post traumatic stress disorder, also known as PTSD, is understood, diagnosed, and treated. Internationally recognized as a leader in the area of traumatic stress, her use of virtual reality to treat people suffering from PTSD has led to the development of treatments that are 2 to 3 times more effective than standard psychological treatments. Her most recent work has involved leading a team of scientists and clinicians to develop a new virtual reality system that allows clinicians to more easily use virtual reality to treat veterans, active-duty personnel, first responders, and survivors of mass shootings with PTSD.

It was a fascinating discussion of the research UCF Restores has accomplished. In one example, Dr. Beidel explained that during the course of the typical VA 17-week Trauma Management Therapy program, anywhere from 28 to 40 % of patients no longer had PTSD, versus 66 to 76 % of UCF Veterans and First Responders in their 3-week trial programs and the relapse rate was significantly lower.

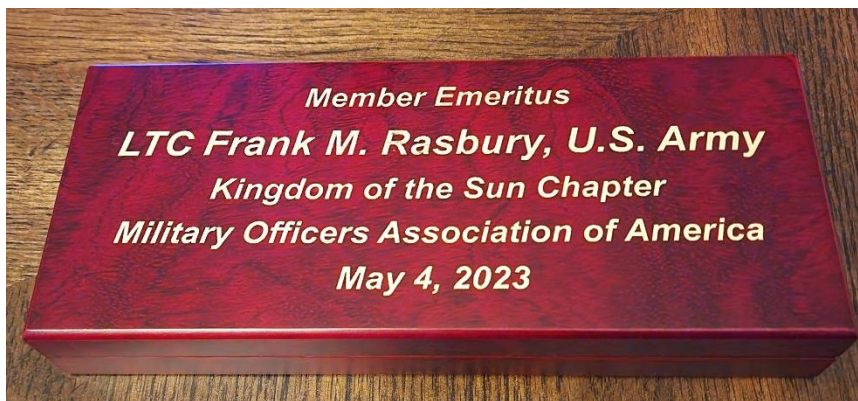

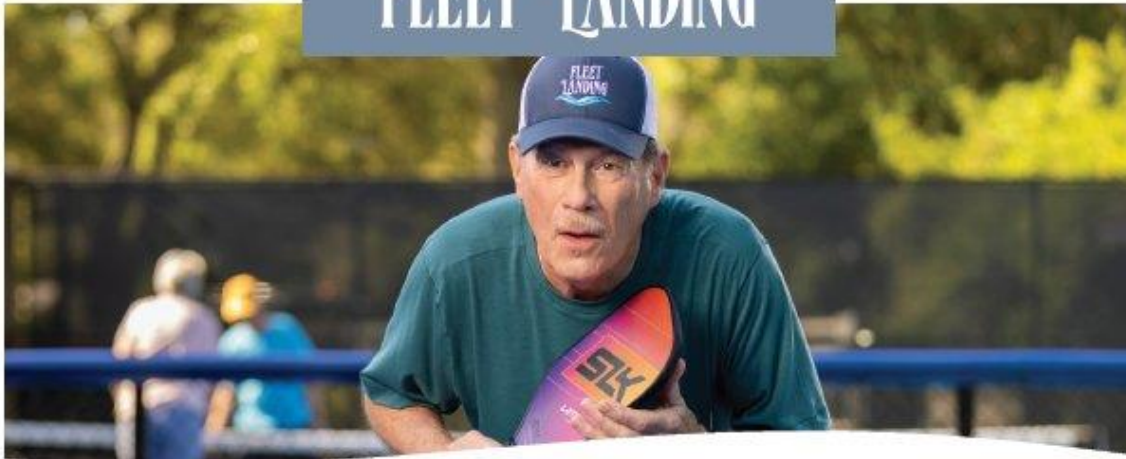
