Greetings MOAA Members and Friends,

We watched the news as Category 1 hurricane Ian quickly developed into a category 4 monster barreling toward Florida's southwest coast. Ian promised terrible ripping winds, devastating tidal surges and potential for historic levels of death and destruction. Our most dense group of MOAA Chapters on Florida's southwest coast lay squarely in the path of this incredibly menacing storm.

One account from a Chapter member shortly after lan's passage; "We had 12 hours of HELL, 155 mph winds and 2 days of rain ... next time we may evacuate......21 hours without power; Cape Coral, Naples Beach, Marco Island, Captiva, Sanibel, all got devastated - complete homes in the river and bay, the causeway bridge to Sanibel and Captiva destroyed, so the only way onto or off is by helicopter or boat."

Ian continued across Florida passing within a mile of Mike Border's home in Sebring where he, Diana

and the South Central Chapter experienced passage of the eye wall. lan's rain and wind kept moving North over our Middle and East Central Area Chapters, and then East to exit Florida near Ron and Nancy Birchall's Ancient City Chapter where St. Augustine's downtown was deluged with flooding from rain and tidal surge, and the historic Flagler Beach pier was destroyed.

As I write this article on Sunday 2
October, several days after lan
pummeled our southwest coast and
much of Florida, our Chapters are
still trying to contact members to
assess injuries and damage. We
hope for good news, anxiously await
any report, and hang on the details of
accounts by survivors. May all of our
MOAA members and their families
come through this ordeal alive and
well.

Vice President's Message

As a chapter leader, I really did not have a good understanding of what the council did. I am sure many in our chapters feel the same. Serving in the council leadership, I now understand the importance of the council and the important work it does for our chapters and for MOAA National as well. The

council is a key element in MOAA's affiliate organizations. Its' purpose is to be an intermediate level "Command and Control" headquarters between MOAA National and our State's thirty-nine chapters. The council leads and coordinates our legislative advocacy efforts at the State-level and supports MOAA's National-level lobbying efforts. We also facilitate the exchange of information and educate chapter leaders, to sustain and build strong, healthy chapters.

One of our unifying missions is Legislative Advocacy. MOAA is a lobbyist organization and they do an excellent job lobbying Congress. At the State-level, the council has the lead to coordinate the efforts of our chapters, providing "grassroots" advocacy for MOAA's legislative initiatives. For example, we are the constituent faces for MOAA's annual Advocacy-in-Action where we coordinate the State-wide efforts to meet with all Florida's 27 Congressional Representatives and our two Senators to ensure they understand what is important to us. We muster support for MOAA's "Calls to Action." A prime example of why numbers matter and the power of uniting members for a specific cause was evident in the recent passing of the "Pact Act." Our collective voices were heard in Congress and resulted in the successful passage of that key legislation. We have a great council legislative team that works to ensure Florida remains veteran and military friendly and monitors State legislation affecting veterans, the serving military, and their families, and issues calls to action to provide support for State legislation when needed.

The council helps sustain and build strong chapters by supplying training for Chapter Leaders and information to conduct chapter business. The primary means to connect the chapters across the state is through this publication and our website. The council also puts a great deal of work into holding Leadership Training Seminars and annual Conventions. At these events, we bring together MOAA reps, council, and chapter leaders to provide training for leaders to run chapters. Why? Because running a chapter (and the council) is like running a business, and leaders need to understand the legalities, policies, procedures, and expectations for conducting the business of the organization. Our Leadership Training Seminar coming up in January is one of the most important events we hold each year, and we encourage all chapter leaders to take part!

This brings me back to our on-going Membership Campaign. The purpose of the campaign is to increase our numbers and build strong chapters. More members mean more depth, with chapters able to provide greater community outreach services, and support for our members. As the slogan goes— "The greater our numbers, the louder our voice!" At our October Board meeting, we will be working with the Area Vice Presidents on implementation of the next steps of the campaign. We also have a session for chapter leaders planned at the January Leadership Training Seminar to share results and ideas among the chapter representatives. The campaign charts and video recording of the 2 August campaign zoom meeting are available for all leaders and chapter



members on the council membership webpage at https://www.moaafl.org/Membership.aspx. I encourage all chapter leaders and members to review the charts as YOU are key to our success—Every member is on the membership committee!

The council is a key element of the MOAA affiliate organization. It coordinates our State-wide activities for legislative engagements, supplies information and training for chapter leaders, and ultimately builds strong chapters. Numbers matter to ensure our voices are heard in Congress or Tallahassee. Strong chapters mean key leaders are trained and implementing MOAA's policies and procedures, are engaged in our communities, and take care of members. The success of our Membership Campaign is key to our ability to do all these things.

Immediate Past President's Message

Foremost on everyone's mind is Hurricane Ian and the aftermath. Hardly a Floridian was unaffected in a direct way. All of us know someone who lost most or almost everything. We know folks who "dodged the bullet." We all worry for our fellow Floridians, our Florida veterans, and of course, our MOAA members, especially those in the path of the storm. I am a Texan, so tornadoes are what I am most familiar with. But not unlike hurricanes, you tend to hunker down and hope for the best. I did live on the Alabama gulf

coast as a child, and remember a hurricane in 1968 that really clobbered us. Hurricane Irma in 2017 went right over my neighborhood. It was amazing. This time, Ian made a return trip. With the



eye so large, our winds were high, and then suddenly there was nearly no wind at all. The other side caught up, but the wind speeds weren't as high. Even though I live inland at nearly an equal distance from both coasts, my county was at 87% with no electricity. This time I was lucky, and among the 13%. Last time, I had no juice for nine days. Still, in both instances, I came out relatively okay. I did have to get a new roof after the 2017 storm. Both times I lost trees, and both times there was massive cleanup to do. Mother nature is guite a force to behold. President Kluever and Vice President Bond mention some of the relief possibilities offered by MOAA National. While it may not be enough to pay for a new roof, every little bit helps. Take advantage of it if you deem it appropriate. Let your fellow veterans know about it.

And life goes on, in spite of the hurricane. Soon the FCoC board of directors will be holding the annual October board meeting by Zoom. The Leadership Training Seminar in Orlando is coming up in January, and we all have the important work of MOAA to do. Whether it be advocacy (MOAA's "Main Battery"), service projects, membership, or your local service projects, we must move forward.

Thanks to all of you for all you do for your veterans and their families. *Never Stop Serving* is all about "Giving Back." Officers are servant leaders whether still in uniform or not. Taking care of the troops is a task never quite finished.

Chaplain's Message

God is our refuge and strength, a very present help in trouble.

Therefore we will not fear, though the earth be moved, and though the mountains be toppled into the depths of the sea;

Though its waters rage and foam, and though the mountains tremble at its tumult.

The Lord of hosts is with us; the God of Jacob is our stronghold. Psalm 46:1-4



As the Chaplain for the Florida Council of Chapters, my monthly reflections for our St. Petersburg Area Chapter are occasionally read by MOAA members across the state of Florida. And this month, with lan a very vivid memory, is one of those months.

As Floridians, we all experienced Ian differently. For some, it was a distant event that we watched on the Weather Channel. For others, it was more personal, and involved possible evacuation, loss of power for a short while, and cleaning up limbs and branches in the yard. But for others, Ian was a nightmare: massive flooding, loss of power for a significant period, and devastation of homes and businesses in the area.

If you experienced lan as a distant event or minor inconvenience, I encourage you to find a way within your community to help those still recovering from the storm. For many areas in Florida, this recovery will be long term (think marathon, not sprint) and assistance will need to be long term as well.

A good rule of thumb in helping after a major disaster is knowing what's needed in the affected area. For example, the victims of Katrina DID NOT need winter clothes. Yes, I was in Mississippi after Katrina and saw that. What might your MOAA chapter, service club, or community of faith offer to assist these devastated areas?

If you experienced lan as a nightmare, my heart breaks for you. As a member of the Florida Army National Guard, I saw firsthand the devastation left by hurricanes. I know the primary focus is tangible recovery: insurance claims, restoration of power, daily living. My job as your chaplain is to remind us about our emotional and spiritual recovery.

With that emotional and spiritual recovery in mind, here are two suggestions. One, take time to grieve and mourn the loss of home, business, and memories after the storm. And by the way, it's OK to be angry with God. The psalms are loaded with the full range of human emotions, including anger.

Two, stay in touch with friends and family and "process" how you are reacting to the recovery. Pay attention to your emotional and mental health and if you sense you need some help, ASK FOR IT. Many organizations will likely deploy people skilled in offering a listening ear and broad shoulder on which to cry in the significantly affected areas. Give yourself grace and space during this marathon recovery.

I leave you with this prayer from the Evangelical Lutheran Church:

Loving God, we come to you trusting in your mercy and knowing that your steadfast love endures forever. Look with mercy on those who are harmed or displaced by Ian. Give them your strength to meet the days ahead, your peace which passes all understanding and new hope in you. Move in those who can give aid, that we may be your hands and heart on earth. Be with all who offer assistance, may your Spirit uphold them. As you have made water a sign of your kingdom, and of cleansing and rebirth, grant your people vision to see new life on the other side of disaster. Amen.





Personal Affairs

After-the-fact: What do you need to do?

Sometimes, a spouse passes on rather unexpectedly. Obviously, there's a major emotional loss. The problem is... there's suddenly a bunch of things

that need to be done and it can quickly become overwhelming.

The following is a list of things that *should* to be done. They are listed pretty much in the order that they should be accomplished. If you've found yourself in this situation, please accept my most sincere condolences. I hope that this list gets you going in the right direction and it saves you some heartburn.

First thing... set up the **funeral** or celebration of life. Take care of you and the rest of the family. The rest is just... paperwork.

The next thing to do if at all possible, is find his **DD-214**, the form that the military issues when someone leaves active duty. You will need it for anything having to do with the military.

Take a blank piece of paper and, at the top, write his **SSN** and yours. Write down the date of death. You will need all of these... repeatedly.

Write down a **list of every financial institution** with which you deal. This is the minimum number of *death certificates* you will need. All life insurance companies will need a long-form death certificate *with* the cause-of-death. The short form should be acceptable for the remainder. Banks, brokerages, and insurance companies will most likely keep the actual certificate. Add four or five death certificates for other uses. The funeral director will arrange these for you. It will take ten days to two weeks to get the actual documents.

Write down a second **list of every company** with which you deal. Think cell phones, cable TV, power companies, and *the county* for jointly held property. Try to find a bill showing your account number and a phone number. These companies will also need to be notified. Your electricity will remain working as long as you pay the bill. But at some point in the distant future, you or your kids will be shutting down the account. If there is any cash remaining, the refund check will be made payable to *both* of you. This can be a real pain.

Write down a list of every **social organization** with which he participated. Think MOAA, college alumni groups, and other veterans groups. Write down every **social media platform** with which he participated. You may want to post something there, assuming you have his password. There's no requirement that you notify these, but it will reduce future mailings from them.

If your spouse was receiving military retired pay, you need to **notify DFAS**, the Defense Finance and Accounting Service. You can call DFAS at 888-332-7411. They will, of course, ask for his SSN and date of death. (Have your paper handy.). They will send you a package of paper to claim the SBP (Survivor's Benefit Plan) payments if he signed up for it.



If your spouse was drawing **VA Disability**, call the VA at 800-827-1000 and report his passing. If he was receiving any corporate pension or federal civil service pension, contact them. The Federal Office of Personnel Management's (OPM) number is 888-767-6738.

If you would like to have your spouse interred at the local **Veteran's cemetery**, the funeral director should be able to make this happen. Or, you can set it up yourself. Fax the DD-214 to the VA at 866-900-6417 or email it to NCA.scheduling@va.gov. (Personal opinion: fax it if possible. Email is totally unsecure. UPS Stores will fax it for less than ten dollars.) If you don't have a DD-214, the VA accepts numerous other documents as proof of service. See the VA cemetery website for the complete list. I would include basic information on the cover sheet such as your contact data with the DD-214 plus a statement to the effect that "Colonel John Benotz passed away on March 20, 2021. We will be requesting internment in a National cemetery."

- Download the cemetery checklist from cem.va.gov. This checklist includes all the questions the scheduler will ask. It includes things such as SSN, service, rank, and desired cemetery. Fax the DD-214 and fill out the checklist before calling them.
- Call the VA Scheduling Office at 800-535-1117. This can be done by a family member or a funeral director. The scheduling office is open seven days a week from 8am to 730pm east coast time. (I called this number while writing this article. Having something else to do while you are on hold for 30-40 minutes is a good idea...)
- 3. Internments are done Monday through Friday.
- 4. If you and your family desire "military honors," the funeral director will request it. DOD requires at least forty eight hours' notice for providing a burial detail. The detail will include two service people in uniform, at least one of which will be from the veteran's service. The detail will fold the flag and present it to the family.

If you want to go for **Arlington National Cemetery**, check their website. It is excellent. Keep in mind that it takes about six months before the burial or inurnment will occur. The phone number at ANC is 877-907-8585.

There is some legal reporting that must be done. Among other things the Will must be "deposited" with the probate court. I understand that one need not use a **lawyer** to do this. I always used a lawyer, though with minimum "probate" items (things titled in the deceased's name alone), the cost was reasonable and the process pretty simple. Among other things, if you own your home jointly with your now deceased spouse, the attorney will prepare and file a "quit claim deed" to put it in your name.

If your spouse was receiving **Social Security**, the Social Security Administration should find out very quickly and turn off his benefit payment automatically. They will also recoup the payment for the remainder of the month after the date of death. Expect to see a withdrawal from your checking account. You can apply for a \$255 death benefit by calling 800-SSA-1213 (800-772-1213) or by going to SSA.gov.

Your status as a spouse of a military person has also changed. You need to update your **military ID**. By far, the best way to arrange this is go to idco.dmdc.old.mil and set up an appointment to get a new ID card. (I really wish they'd change that to "militaryID.gov" but what do I know?)



Now... it's time to start working that list of **financial institutions**. There's no easy way of doing this. Just start with the biggest and notify them of your spouse's passing. Each will have their own paperwork requirements. Expect it to be tedious and be happy if it isn't. The important thing is to get them all so that the accounts are in your name.

If your spouse had a **life insurance policy**, contact that company. They will normally send you a claim package with instructions on how to initiate a payout. Back in the *olden days*, they would simply mail you a check. Now, they will ask you if you'd like to do direct deposit or mail a check. If you do direct deposit, make sure it's going to an account for which you are the primary or sole owner. If you send it to a joint account that has your now deceased husband's name getting top billing, it might get lost in no-man's-land. You'll eventually get it, but it will be only after a boatload of heartburn.

Some other comments on life insurance: Some insurance companies will give you the choice of a check or a *checkbook*. (They want to *keep* the money...). You probably have enough accounts already. Take the money. Some will offer you an annuity. I'd still take the money.

Also, if your spouse also retired from a **major corporation**, check with the HR department. Most big companies offer something like two times one's salary as life insurance to current employees. They might have a life insurance benefit on retirees. I checked the website for my father-in-law's company and *son-of-a-gun*, they sent fifteen grand to my wife.

Once the financial institutions are done or in-the-works, start on the **companies** with whom you deal. Interestingly, as long as you pay the bill, your cell company, your cable company, and your electric company will continue providing service. The problem comes if it's necessary to settle *your* affairs. Most of these companies will make refund checks payable to both your names, even if one spouse died years ago. If these companies require a death certificate, they will normally accept a photocopy.

Then it's time to start working on **social organizations.** Be sure to contact your local chapter of MOAA as well as **MOAA National**. You can call National at 703-549-2311. If your spouse was a life member of MOAA National, that membership transfers to you. College Alumni organizations will normally list your spouse's name in their bulletin.

There's no requirement that you do anything about **social media**, such as Facebook. On the other hand, I know that I have managed to connect on Facebook with a lot of people around the planet with whom I served forty years ago. We're *not* as *lean*, *nor not* as *mean*, but we now share pictures and exploits of our grandkids. I hope that when it comes time to settle my affairs, those I leave behind will post on my Facebook page that I've "departed on my final deployment." My buddies will appreciate it.

None of this is easy, and it should be done sooner than later. At the same time, you just went through an incredible emotional shock. Don't drive yourself crazy getting it done.

On the national level, there were two webinars recently offered by MOAA; one on Estate Planning and the other on Preparing a Spouse

<u>Spouse Licensure, School Policies Top DoD-State Liaison Group's 2023</u> Priorities

Improved spouse licensure laws and military-friendly school policies top the 2023 priorities for the <u>Defense-State Liaison Office</u> (DSLO), which works to alleviate barriers resulting from military life and harmonize the differences in state and federal laws.

DSLO's efforts at the state level have led to 33 states enacting supportive licensure laws and providing expedited processes to achieve a baseline of a license within 30 days with minimal upfront paperwork from licensed military spouses.


DSLO, in conjunction with licensing boards, has developed eight interstate compacts (nursing, advanced practice registered nursing, emergency medical services, physical therapy, audiology/speech-language pathology, licensed professional counseling, occupational therapy, and psychology). At least 44 states have signed on to at least one of these compacts, with 35 states signed on to three or more compacts.

The office is continuing work to develop compacts for teaching, social work, dentistry/dental hygiene, massage therapy, cosmetology/barbering, school psychology, and dietetic nutrition.

You may recall that during the 2022 Florida Legislative session the FCoC promoted an advocacy campaign targeted on our state senators and representatives for several bills addressing barriers to military spouse licensure when transferred to the state upon their service-members assignment here. Each of those bills were in line with the MOAA supported DSLO priorities for 2022.

We may never know what impact our campaign had on the legislators' votes, but we do know that at the committee levels as well as in the floor votes in each chamber, **three bills were passed unanimously.** Despite that success, there is still more that needs to be accomplished.

None-the-less the Florida record depicted on the map above is better than it looks. The work to introduce additional legislation on licensure of military spouse professionals continues.

In August our regional DSLO representative, Eric Sherman briefed the **Florida Defense Support Task Force (FDSTF)**, including the **Family Support Working Group** on the benefits to military families of state supported Professional Licensure Compacts to facilitate Military Spouse employment opportunities. The briefing addressed

- License Portability for Emergency Medical Services Professionals
- Interstate Compacts for Occupational Therapy Professionals, Psychology Professionals, and Audiology Speech Language Pathology professionals.



The FDSTF (with members from both houses of the Legislature on the committee) are planning to find sponsors to introduce at least two bills to address the open issues on the DSLO priorities list.

One of the elements in the FDSTF mission is: **Strengthening state support for military families** and veterans with a focus on education, health care, employment and **family programs**

The FCoC will again be promoting an advocacy campaign to request support from our legislators when the new bills enter the committee hearings process and then through the floor votes leading to the governor's signature. A process very much like what we do at the federal level.

Advocacy engagement with our state legislators is an important mission complimenting the DSLO's efforts with the FDSTF.

NDAA and Budget Bills Stalled as the Fiscal Year Wraps Up

Without the necessary authorizations and appropriations, federal agencies can't operate properly. An authorization bill establishes new policies and programs for a federal agency and can reauthorize programs set to expire, while appropriations provide the funding for those authorizations.

Until Congress passes those bills, federal agencies overseeing the eight uniformed services lack the authorizations or funding needed for the annual military pay raise, quality health care coverage, and quality-of-life programs for servicemembers and their families, along with many other support programs and benefits necessary for an all-volunteer force.

The last time Congress and the White House enacted the necessary legislation on time to fully fund the government for the upcoming fiscal year was for **FY 1997**. With the start of FY 2023 upon us, followed by midterm elections, it's very likely the government will again miss the mark with its budget process.

The National Defense Authorization Act (NDAA) affects DoD policies and programs. The House passed its version of the NDAA on July 14 by a vote of 329-101. The Senate has yet to take up never mind pass its version. So the House version remains in limbo.

For a quarter of a century, Congress and the White House have failed to enact the necessary legislation to fully fund the federal government on time, and the ones who ultimately suffer the most are servicemembers, veterans, survivors, and their families.

Take Action: Ask Your Senators to Preserve Key Benefits in the FY 2023 NDAA

STANDBY for URGENT MOAA requests on messaging to pass those appropriations and for the subsequent votes for extensions to the temporary deadlines.



And ... Another FY Starts Under a Continuing Resolution

The day before the end of FY-2022, the Senate passed HR 6833, the Continuing Appropriations and Ukraine Supplemental Appropriations Act, on a bipartisan vote of 72-25, extending government funding until December 16th. For the record Senator Rubio did not vote and Senator Scott voted No.

The House took up the Bill on September 30th, which passed on a 230-201 vote. For the record, the Florida delegation voted strictly along party lines.

In addition to extending government spending at current levels, the Bill included more than \$12 billion in security and financial assistance for Ukraine, an additional \$18.8 billion for the FEMA Disaster Relief Fund, \$2.5 billion for wildfires in New Mexico and \$1 billion for home heating assistance.

President Biden signed the Bill before the midnight deadline thereby avoiding a government shut down until December 16th.

Ask Our Lawmakers to Join their Colleagues who have Already Shown their Support on Hiring Incentives for Military Spouses

While DoD and military family nonprofit organizations provide programs designed to give military spouses opportunities for enhanced education, professional development, and upskilling, the other side of the equation is **incentivizing businesses to hire someone** they know will likely move within two to three years. Adding military spouses as a target group under the Work Opportunity Tax Credit laws should be the next step.

The **Military Spouse Hiring Act H.R. 2974 & S.3909** will create a new WOTC target group for military spouses, which will provide employers with a \$2,400 tax credit to help offset hiring and onboarding costs. MOAA is working closely with the National Military Family Association to gather as many co-sponsors as possible before December in the event Congress puts forth an end-of-year tax-extenders package, which could include this bill.

Preserve Burial with Full Military Honors for Military Retirees

MOAA's work to preserve the national cemetery benefit for military retirees continues, however, the need for grassroots action remains: Reach out to your elected officials ask them to become original co-sponsors on legislation to expand options for honors at a VA cemeteries under the Expanding America's National Cemetery Act.



"Arlington National Cemetery in-ground burial will not reach capacity for 42 years with the current standards," said Gen. Walter L. "Skip" Sharp, USA (Ret), MOAA's chairman of the board. "This leaves time to <u>develop a new location</u> and to slowly transition <u>while maintaining current</u> <u>eligibility for all those who have planned for in-ground burial at Arlington."</u>

There are 155 VA-run national cemeteries, with many adjacent to a military installation. The **Expanding America's National Cemetery Act** will authorize DoD and the VA to transform an existing VA-run national cemetery into the next location that will afford interment with full military honors as ANC reaches capacity.

Time is running short this legislative year, with many lawmakers focused on midterm elections. Ask your lawmakers to sign on as an original co-sponsor to protect this important benefit.

What's Happening on Concurrent Receipt for Medically Retired Members

The Major Richard Star Act HR 1282 & S-344 have been on MOAA's Legislative Priorities agenda since the early spring when the *Advocacy in Action* Campaign kicked-off. There have been several Calls-to-Action from MOAA and from the FCoC asking that we contact our legislators to support the Bills and sign on as co-sponsors. Over 10,660 actions have been taken so far through MOAA's messaging system.

STATUS in the House

On August 9th The Major Richard Star Act reached a milestone goal of 290 co-sponsors in the House with 6 new co-sponsors (including Jose Diaz-Balat FL-25). Cong Gus Bilirakis (FL 14) who introduced the bill announced this achievement saying

"Pursuant to House Rules, I filed a petition [on August 12th] to have my Major Richard Star Act placed on the House Consent Calendar because it reached the required threshold of garnering 290 cosponsors.

This critical legislation will rectify an injustice that keeps combat disabled Veterans from receiving full military benefits. Currently, over 50,000 medically retired veterans are forbidden from receiving their full retirement pay and disability compensation.

My bill will repeal this unfair offset, allowing these disabled Veterans to receive both their retirement pay and their disability compensation.... I look forward to getting this bill across the finish line!"

As of September 22nd the bill now has 314 co-sponsors – among the latest to sign on are Val Demings (FL10) and Ted Deutch (FL 22).

Lt. Gen. Dana T. Atkins, MOAA's president and CEO, was quoted in a Press Release from Cong Bilirakis' office saying:



"MOAA and other ardent supporters have diligently carried this torch to garner support and make way for those injured in combat to be eligible for their retirement pay. We encourage the 117th Congress to solve this injustice this year – we still have time to get it done."

STATUS in the Senate

Sen. Jon Tester (D-Mont.), chair of the Senate Committee on Veterans' Affairs, will submit the Star Act as an amendment to the chamber's version of the FY 2023 National Defense Authorization Act (NDAA). **The Star Act is his top priority for amendments to this year's NDAA**.

The push is on to increase the number of co-sponsors in the Senate to show support for the Chairman's legislative strategy to deliver this remedy to the 50,000+ medically retired servicemembers and their families that have been paying the burdensome "tax" on their retired pay. **Neither of Florida's Senators have signed on**

Combat-injured veterans would benefit from long-sought changes to unjust compensation practices if the Star Act becomes law, either as a standalone measure (a possibility in the House) or as an NDAA amendment in the Senate.

If this approach is successful, the joint committee charged with reconciling the differences between the already approved House NDAA and this Senate version will likely include the provision in their version which goes back to both chambers for a final up or down vote

Could Congress Come for Your COLA? By: Dan Merry

Congress has an enduring history of tapping into COLA at the expense of your retired pay, and it could very well happen again.

As we inch toward what could be the largest growth in COLA since 1982, when it came in at 8.7%, we remain guarded as to any current attempts by Congress to reduce, in any fashion, the legislated protections of the purchasing power of retired pay, survivor and veteran benefits, and Social Security. We have many reasons to be wary of such covert efforts. Check out this link the history of COLA attacks is well documented.



Projected CPI increases based on the August 2022 Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) is 8.6% above the FY 2022 COLA base line. The significance of this annual adjustment warrants a close look on two fronts:

- 1. Congress could channel some of the increase into their efforts to control outlays in response to the growing national debt.
- 2. The high COLA holds broad personal implications -- after all, the increase is tied directly to inflation, which results in higher costs across the board, including your TRICARE benefits.

Stay tuned for updates and potential calls to action. MOAA will continue to work with TMC to ensure all of our eight uniformed services continue to receive COLA increases per current legislation.

MOAA Florida Chapters have a unique opportunity to partner with the Florida Department of Veteran Affairs (FDVA) and help sponsor a location to hold Town Hall Vietnam

Veterans meetings around the state of Florida. Topics include Toxic Exposure Awareness and help with benefit information for those Vietnam Veterans who have been exposed to a toxic environment, to include Agent Orange and illnesses outlined in the PACT Act. MOAA National's successful advocacy efforts helped pass the PACT Act that has been signed by the President. This is a great opportunity for a MOAA Florida Chapter to work together as a team with FDVA to help our Vietnam Veterans who have been exposed to Agent Orange, Burn Pits, and Camp Lejeune water and other toxic environments. MOAA Chapters that have a high population of Vietnam Veterans who have been exposed to Agent Orange illnesses and other illnesses outlined in the PACT Act will work with the FDVA in securing a place to hold the Vietnam Veteran Town Hall meetings. The MOAA Chapter will help get the word out to their local community, and if we have any experienced Veterans who can speak on the legislation and VA benefits, that would be an added plus. This initiative is coming from MG (ret) Hartsell, the Executve Director of FDVA, and the FDVA Communications Directorate will take the lead for presenting information and logistics of running the Town Halls. So far, we have two MOAA Chapters who have stepped-up to host a future Town Hall. There are other VSO's who have been asked to hold a Town Hall, but with 40 MOAA Chapters in Florida, we hope to take the lead on hosting the Town Halls.

FDVA is looking to have 12 Town Hall Vietnam Veteran meetings around the state and is relying on various VSO organizations to help scout out areas with a high population of Vietnam Veterans. If your Chapter fits this criteria and wants to apply to host a Town Hall, please forward your details

Ten Florida Veterans Inducted Into Hall of Fame

TALLAHASSEE -- Gov. Ron DeSantis and the Cabinet voted unanimously to induct 10 Veterans into the Florida Veterans' Hall of Fame. The names for the Class of 2022 were presented for a formal vote during the Aug. 23 Cabinet Meeting by FDVA Executive Director James S. "Hammer" Hartsell.

The Florida Veterans' Hall of Fame recognizes and honors those military Veterans who, through their works and lives during or after military service, have made a significant contribution to the State of Florida through civic, business, public service or other pursuits. The hall of fame focuses on post-military contributions to the State of Florida.

"It was my honor to endorse and submit the names of these 10 distinguished Veterans for inclusion in the Hall of Fame," said Hartsell, a retired Marine Corps Major General. "These former service members join nine previous classes in representing the best of our Veteran community and we look forward to honoring them in person later this year. Honoring our distinguished inductees each year helps reinforce Florida as the most veteran sought after state in the nation."

The Florida Veterans' Hall of Fame Council met earlier this year to review and select nominees submitted from the general public. Following a formal report and audit, the results were transmitted to the Florida Department of Veterans' Affairs, which submits the nominations to the Governor and Cabinet. The Aug. 23 vote formally approves the selection.

The Class of 2022 is the 10th class to enter the Florida Veterans' Hall of Fame.

Governor Encourages Veterans to Apply for Temporary Teaching Certificates

TALLAHASSEE -- Gov. Ron DeSantis announced Aug. 11 the launch of a new webpage to help recruit qualified military Veterans to join schools across the state. The State Board of Education passed a rule Aug. 17 to formally implement a program for veterans to receive a five-year temporary education certificate while they finish their bachelor's degree, provided they meet certain criteria. The rule implements SB 896, which Governor DeSantis signed earlier this year after it received unanimous bipartisan support throughout the 2022 Session.

"Florida is the most Veteran- and military friendly state in the nation," said Gov. Ron DeSantis. "We also know that our Veterans have talents and skills that they can offer our students. This new opportunity expands Florida's existing programs that help our Veterans take their talents to our schools, and it will help Florida remain a national leader in education."

Military Veterans Certification Pathway

The State Board of Education rule allows military Veterans to obtain a 5-year temporary teaching certificate without a bachelor's degree, providing the following criteria are met:

- Minimum of 48 months of military service with an honorable/medical discharge:
- Minimum of 60 college credits with a 2.5 grade point average;
- Passing score on a Florida subject area examination;
- Employment in a Florida school district, including charter schools; and
- Cleared background screening.

Per SB 896 (2022), which unanimously passed the Florida House and Senate, Veterans who successfully obtain their 5-year temporary teaching certificate will be assigned a mentor teacher for a minimum of two years to support their classroom teaching endeavors. They must also earn their bachelor's degree during the 5-year period to be eligible for a full professional certificate. Veterans utilizing this temporary certificate may not teach subject areas that require a master's degree. The temporary certificate cannot be renewed once it expires, nor does it apply to military spouses or families.





Captain Jason Schneider - MOAACC Guest Speaker

The August MOAACC luncheon speaker was Captain Jason Schneider, who is the Commanding Officer of the Naval Ordinance Test Unit (NOTU). NOTU provides a key component of the nation's strategic nuclear deterrence mission and supports naval activity above, at, and below the surface of the sea. The command has operated for over 65 years, supporting strategic deterrence and systems production for the Navy, through both ground-based and missile flight-testing and support.

Every generation of the submarine launched ballistic missile system---Polaris, Poseidon, and Trident-----has been tested at the NOTU facility, from the design and development phase all the way through sustainment and operational support. NOTU's Strategic Weapons System Ashore Facility supports testing for current OHIO-class submarines, as well as future engineering needs for systems pertaining to COLOMBIA-class submarines, which is the Navy's most important acquisition priority today.

NOTU also operates the Navy's port at Port Canaveral, supporting submarines and surface ships of the US Atlantic Fleet, foreign navies, and assets of the Military Sealift Command.

Captain Schneider is a graduate of the US Naval Academy, and earned Master's degrees from George Washington University and the US Naval War College. He qualified in submarines as a junior and Executive Officer aboard several nuclear submarines. Ashore, he served as the Submarine SONAR Sensors Team Lead and Operational Test Director on the staff of Commander, Operational Test and Evaluation Force; as a legislative fellow on the staff of Senator Jack Reed; as a capability developer at US Joint Forces Command (USJFCOM); and as Commander, Submarine Forces Atlantic.

The September MOAACC luncheon speaker was LTC Ken Harris, who provided insights into the Joint Task Force (JTF) Guantanamo Bay (GITMO). He discussed the two separate parts of Guantanamo, the actual Naval Base and the Center for Detainees. These detainees are Muslim militants and suspected terrorists captured by U.S. forces in Afghanistan, Iraq, and other places. Harris described how attempts are made to satisfy their cultural dietary and religious requirements to the extent possible.

LTC Harris has enjoyed a varied military career. He enlisted in the US Navy in 1982. After some time at sea, he attended and graduated from the US Naval Academy in 1989, completing 4 years of Active Duty aboard a new destroyer. The theme of the 2022 Veterans Appreciation Week is "Citrus County Honoring our Afghanistan and Iraq Veterans". With over 20 years of strong support by the Citrus County School District, the VITC program has educated thousands of our county's children on the importance of our Veterans military service. The VITC program is managed by the Military Officers Association of America (MOAA) Citrus County chapter and the program manager is COL Mark Bodenheim, USA (Ret), a 39 year military service veteran with three mobilization tours. He states, "Since 2019, we have lost over 20% of our Veteran presenters due to illness, death or moving out of the county. In a county with over 20,000 Veterans, we should have a lot more than the 60 Veterans on our current contact list. We need to get the

message out there that we need Veterans to step up to this mission."

In coordination with Mr. Al Balk, the Citrus County School District, Social Studies Teacher On Special Assignment (TOSA), COL

Bodenheim developed a digital registration process which makes it easier to match Veterans with teacher requests for particular skill sets. COL Bodenheim states, "I have teachers requesting cooks, band players, helicopter pilots, accountants or foreign language speaking Veterans. The digital registration process permits me to match the Veteran's skill sets to a teacher's request."




